DRAFT AMENDED CONSTITUTION OF THE OUR PARTY

PREAMBLE

We, the members of the OUR Party, inspired by the principles of democracy, justice, unity, and inclusivity, hereby adopt this Constitution to establish a framework for ethical governance, social equity, and national development. Committed to the long-term prosperity and well-being of our people, we enshrine these values to guide the Party's leadership, policies, and operations. This Constitution reflects our resolve to address the challenges of today while preparing for the opportunities and responsibilities of tomorrow.

ARTICLE I: NAME AND OBJECTIVES

1. Name

The name of the Party shall be the **Ownership**, **Unity and Responsibility** (OUR) **Party** (hereinafter referred to as "**OUR Party**").

2. Objectives

The objectives of **OUR Party** shall be to:

- (a) Uphold and promote democratic governance, transparency, and accountability in all aspects of public life.
- (b) Ensure equitable social, economic, and political development, fostering inclusivity and reducing inequality.
- (c) Champion human rights, civil liberties, and the rule of law, with a commitment to freedom of speech, media independence, and peaceful assembly.
- (d) Foster national unity, reconciliation, and cohesion, respecting and protecting the diverse cultural and ethnic identities of the nation.
- (e) Promote sustainable development, environmental stewardship, and climate resilience to safeguard the nation for future generations.
- (f) Advocate for innovation and technological advancement to modernize public administration and enhance national competitiveness.
- (g) Uphold international cooperation and diplomacy, promoting peace and stability regionally and globally.

ARTICLE II: MEMBERSHIP

1. Eligibility

Membership of the Party shall be open to all citizens of the nation who subscribe to the Party's principles and objectives, regardless of race, gender, ethnicity, religion, or socioeconomic status.

2. **Rights of Members**

All members shall have the right to:

- (a) Participate in Party activities, discussions, and decision-making processes.
- (b) Run for leadership positions within the Party, subject to the rules and regulations set forth by the Executive Committee.
- (c) Propose policies and initiatives in alignment with the Party's objectives.

3. Obligations of Members

All members shall be obligated to:

ARTICLE III: PARTY STRUCTURE AND LEADERSHIP

1. Executive Committee

The Party's leadership shall be vested in the Executive Committee, which shall be responsible for overseeing the administration, policy development, and strategic direction of the Party.

2. Composition

The Executive Committee shall consist of the Party Leader, Deputy Party Leader, President, Vice President, Secretary-General, Treasurer, and other officials as appointed by the Party.

3. Term

Executive Committee members shall serve a term of three (3) years, subject to re-election.

4. Elections

The election of Executive Committee members shall be conducted transparently through a democratic voting process by the Party's General Assembly.

5. Advisory Council

The Party shall establish an Advisory Council composed of senior Party members and external experts, who shall provide strategic advice on national and Party matters.

6. Composition:

The Advisory Council shall include former Party leaders, senior officials, and specialists in relevant fields, including economics, law, and international relations.

ARTICLE IV: COMMITMENT TO DEMOCRACY AND GOOD GOVERNANCE

3. Youth Empowerment

3.1. The Party recognizes that the youth are the future leaders of the nation and shall create opportunities for their active involvement in Party and national leadership.

3.2. A Youth Wing shall be established to represent the interests of young people and develop future leaders through mentorship programs and leadership training.
